Introduction

The New Zealand Archive of Film, Television and Sound Ngā Taonga Whitiāhua Me Ngā Taonga Kōrero (operating name Ngā Taonga Sound & Vision) encourages the reproduction of items from its collections. Some of the Documentation collection contains many items that have been acquired by bequest, donation or loan. Some of the items are still in copyright while others have been accepted under special conditions.

Ngā Taonga Sound & Vision has a responsibility to ensure the material in its care is used in a way consistent with the undertakings made at the time of acquisition, which recognises cultural and personal sensitivities, and to uphold the integrity of the original item. These conditions apply to all reproductions of items held by Ngā Taonga Sound & Vision.

1. Conditions of use for reproduction or display

These conditions apply to all reproductions for publication, or exhibition, of photographs, slides, posters, publicity, written and unpublished material held by Ngā Taonga Sound & Vision. Props, equipment and costumes held by Ngā Taonga Sound & Vision are not generally available and are dealt with on a case-by-case basis.

2. Copyright

Every effort is made to ensure that the collection is free of legal restrictions and available for public use. However, the responsibility for clearing copyright and for meeting the requirements placed on an item rests with the client. Ngā Taonga Sound & Vision will assist where possible. Copyright clearances must be obtained before any material is released.

3. Format of reproduction

In order to maintain quality, Ngā Taonga Sound & Vision will provide duplicate digital files, from its collections. Ngā Taonga Sound & Vision does not allow collection items to be reproduced directly from an existing publication or website. Nor does it allow images to be re-photographed. Cropping and manipulation of an image is allowed only with permission from the Ngā Taonga Sound & Vision.

4. Authorisation

Ngā Taonga Sound & Vision's permission must be obtained before collection items can be reproduced or displayed. Ngā Taonga Sound & Vision reserves the right to refuse applications. All reprints, further editions or reuse require a new application and are not covered by the original permission or fee. *All material released remains the property of Ngā Taonga Sound & Vision and must be returned after use. Digital files must be deleted from the Client's computer immediately after use.*

5. Acknowledgement

Ngā Taonga Sound & Vision will supply an acknowledgement that must accompany all reproductions and displays.

6. Charges

A supply and handling fee per digital file is charged. This fee is based on the recuperation of staff time and resource costs taken to fulfil a request. Additional costs may be incurred if we need to externally outsource the digitisation of collection materials.

Charges do not include copyright charges, which may be applied by the copyright holder. Ngā Taonga Sound & Vision's standard contract must be signed before items are released.
